
Research Methodology

Five repetitions of randomized complete blocks. Each plot was 30 linear feet on a row width that created an area equivalent to 0.00344 acres.


Application Rates

STOCKOSORB® 660 was applied at a rate of 20 pounds per acre of treated soil, incorporated into the top 6 inches of soil.

Conclusion

At a wholesale price of only \$0.51 per lb. (avg. tomato wholesale price in 2008), this shows a return of \$1,086.30 (2130 lbs. x \$0.51per lb.), minus STOCKOSORB® cost (\$180) resulting in a net profit per acre of \$906.30.
